Same day first of all children were collect and children parents come, that let us we doing prayer for god for save the children and then given brief information about CHILDLINE and its toll free number i.e. 1098. Child line team play NUKAAD NATAK them for Nasha Mukkti, Child labour & Child Marriage, Child Missing.

They were told about Child Rights and whom to approach in case of violation of their rights either in Coaching institute, school, in community & Village or any other place. In case of any abuse they were told to call 1098



which is toll free number. Children were encouraged to participate in the discussion. Then children were given platform to do whatever they like such as Movie Display, dancing, telling story, poems etc. Most of the children came forward and performed according to their ability. CHILDLINE pamphlets was distributed to each children, community & Village members, teachers present

Canopy & Outreach awareness program

Canopy was organized August & September Month at Khade Ganesh ji area & Kishor talab Pal during Tajaji mela & Ganesh Chaturthi and about Child line introduction. Canopy inauguration by Mr. Vimal chand Jain Former. CWC member kota. Information was given to approximate 1128 children and people. The team members distributed and showed the CHILDLINE pamphlet and create propaganda nature. CHILDLINE Kota organised canopy awareness and invited many people and share about the child line and its toll-free number 1098, this number is 24 hours run to support of children who is suffered from any problems and child tell us and our team help within minimum time.

One day workshop for "Prevention of Child Labor"

Child line organized a day-long workshop for "Prevention of Child Labor" on 13 June 2019. In this one-day workshop, stakeholders related to all children participated and gave their suggestions for prevention of child labor.

Oath program for "prevention of child marriage".

Signature campaign and oath program for prevention of child marriage was organized by Child Line on 1 June 2019. Most of the institutions of the city participated in this event and their officials gave their views. After this, everyone signed and gave their consent for the prevention of child marriage and then took the oath collectively.

One day workshop for "Prevention of Child Marriage".

DALSA kota organized a day-long workshop for "Prevention of Child Marriage" on 03 May 2019. In this one-day workshop, stakeholders related to all children participated and gave their suggestions for prevention of child marriage. After this, everyone collectively took an oath to prevent child marriage.

One day training program on "Juvenile Justice Act 2015".

One day training program on "Juvenile Justice Act 2015" was organized by Child Line Kota on 27th September, 2019 in which the team of SJPU of the district RPF, GRP, Child Welfare Committee, Juvenile Justice Board, Child Line Quota and Railway Child line etc. stakeholders participated. Additional Superintendent of Police Kota presided over the workshop. For training mainly former member Children Commission Rajasthan Shri Govind Beniwal was present along with other trainees of the district also imparted training to all participants on JJ act,

2015. During the training, all the participants discussed and answered questions openly about better rehabilitation of children in the kota district.

Child Abuse case

A call came on 1098 on 20.07.2019 from Kethuni pol by Sandep ray that 12 year girl child sexually abused by Sister Father in law. After the call team member contact to caller and explained the whole matter. After some time team member went there and met girl child. After the met our team member and girl child relative reached police station Kethunipol and inform to Duty officer. After the information and Statement girl child Police file FIR agensed accused in Under Section POCSO Act, 2012 and Under Section IPC. After the FIR Team member produced in front CWC Kota. So CWC Kota order to temporary shelter Government girls home at Nanta kunhari Kota. Given the application in the DALSA for victim compensation by team member. Police proceedings are still to start. After given a follow up by team member to CCC North and case close

Rescue 02 Child labor

A call came on 1098 on 18.09.2019 from Rajeev gandi nagar by Shobhi ji that some children are working in Saras shop Rajeev gandi nagar Kota city. After the call Center Coordinator and team member went there and found some children are working in Saras shop Rajeev gandi nagar kota city. So team member reached police station Jawaher nagar and make them aware of the whole case. After some time the Jawaher nagar police team and Child line team reached the spot and with the help of police team, children were freed from Child-labor. After the DD entry and wireless Police & Team member produced in front CWC Kota. So CWC order to temporary shelter Utkarsh Shelter home at Talwandi Kota. After CCC north follow up case.

Child marriages stopped Girl child

A call came on 1098 on 05.07.2019 from Ranpur Kota city by yagyadaat hada ji . He informed a girl child is getting married in District kota Thasil ladpura, Antpura police station Ranpur area and she is under 18 years of age. So please come here and help the girl child and stop the child marriage. After the call team member inform to CWC kota & Child marriage control room and make them aware of the whole case. Child line team reached Antpura police station and met Ramnarayn Meena. Child line team and police reached girl child home and after age verification, police cabined the Child guardian and these marriage stop. The police introduced the family of the girl to the regional court and according to the Child Marriage Prevention Act 2006, the Regional Court had banned the family. After given a follow up by team member to CCC North and case close

Shelter given to Girl child

A call came on 1098 on 01.05.2019 from RPF Police station by Jai shree that found girl child and she is missing. This is matter of need care and protection. So please come here and provide shelter. After the call team member went there and met girl child. After the DD entry and wireless Team member produced in front CWC Kota. So CWC order to temporary shelter Government girls Shelter home at Nanta Kota. After given a follow up by team member to CCC North and case closed.

Rescue 04 Child labor

A call came on 1098 on 10.04.2019 Borkheda by Ashiq Ali ji HC AHTU Kota rural that some children are working in different - different Shop at Kethun Kota rural area. Please come here and help the children. After the call team member went there and met AHTU team. After some time the AHTU team team and Child line team reached the spot and with the help of AHTU team, children were freed from Child-labor. After the DD entry and wireless Police & Team member produced in front CWC Kota. So CWC order to temporary shelter Utkarsh Shelter home at Station Kota. After given a follow up by team member to CCC North and case open.

Canopy & Outreach awareness programme



This year also, canopy was installed at various places like in the past and outreach was done at different places. Canopy was organized September, 2019, Feb, 20 & March, 19 in the year on the occasion of Tejaji's fair and Anant-Chaturdasi & Kishor talab Pal during Mahashiv ratri mela the people were made aware by the child line kota team through Canopy. Were distributed pumlet to people coming to the fair and about 3060 children and people were made aware. The people were told that if they saw any child in trouble, then call on 1098 and get help and protect the rights of children.



During this year, the childline team provided childline information to the people by outreach at , coaching & rural areas etc. The people were told that if they saw any child in trouble, then call on 1098 and get help and protect the rights of children.In the meantime, the passengers present on the railway station were informed about the information of the childline that if they see any missing child / girl during the journey, they should immediately call 1098 and help the child. During the outreach, the team informed the coaching students that they should never feel stress, they need any help, they can get help by calling 1098.During the outreach itself, the children made the team aware of their problems, the team intervened


